#### Los Esteros Critical Energy Facility Low-Effect Habitat Conservation Plan for the Bay Checkerspot Butterfly and Serpentine Endemic Plant Species, Santa Clara County, CA

**AGENCY:** Fish and Wildlife Service, Interior.

**ACTION:** Notice of availability; proposed low-effect habitat conservation plan; request for comment.

**SUMMARY:** We, the U.S. Fish and Wildlife Service, have received an application from the Calpine Corporation (applicant) for a 50-year incidental take permit for five species under the Endangered Species Act of 1973, as amended (Act). The application addresses the potential for "take" of one federally listed animal and four federally listed plants. The applicant would implement a conservation program to minimize and mitigate the project activities, as described in the applicant's low-effect habitat conservation plan (plan). We request comments on the applicant's application and plan, and the preliminary determination that the plan qualifies as a "low-effect" habitat conservation plan, eligible for a Categorical Exclusion under the National Environmental Policy Act of 1969, as amended (NEPA). We discuss our basis for this determination in our environmental action statement (EAS), also available for public review.
